SUBMISSION DISCLAIMER

To ensure a prompt and speedy process, license request submissions must adhere to the following criteria:

- License request form must be sent along with submitted material (CD+ Artwork).
- License agreement must be reviewed, completed, and mailed back in a timely fashion.
- Submission of an audio CD with artwork makes ingestion of your material into the BurnLounge store the easiest.

There may be a delay in ingestion of your submitted material should any of the following issues arise:

- Submitted material contains sampled tracks, cover songs or vocals without proper clearance. If this issue lies with certain tracks of the submitted album, material must be re-submitted without those specific tracks. BurnLounge will not remove tracks from albums.
- Submitted material must be examined prior to submission for scratched, damaged, or skipped tracks. We will not be able to ingest your material if this occurs, and the process will ultimately take longer to complete.
